## MEDIA ACCREDITATION REGULATIONS

We invite you to read the media accreditation regulations for the second round of the FIA European Autocross Championship.



## BASIC PRINCIPLES OF ACCREDITATION

When submitting an accreditation application, the media representative commits to correctly informing the audience of the media outlet about the event both before and after it takes place. The media representative uses the official event name: EAX BAUSKA 2025.

### Media representatives accreditation is intended for:

- Journalists
- Media photographers
- Video cameramen
- Team officials

Accreditation can be granted to individuals who, at the time of application submission, have reached the age of 18. A certain number of accredited media representatives will have the opportunity to use remotely piloted aerial vehicles (drones), provided this is coordinated with the event organizers and a written permission is obtained in advance.

## MEDIA VESTS

Media photographers, radio correspondents, and cameramen who wish to receive media accreditation and media vests, as well as be present at the trackside locations, are required **to have a valid personal accident insurance policy (including for sports competitions) with a minimum coverage of 3,000 EUR.**

**Accredited media representatives can receive media vests for a refundable deposit of 20 EUR.**

Those with a media vest issued by the event organizer are permitted to be present in the trackside areas, but no closer than one meter to safety barriers (such as fencing, tapes, etc.).

**Media vests and media accreditation are strictly prohibited from being transferred to other persons.**

## ACCREDITATION APPLICATION SUBMISSION AND APPROVAL

The event organizer does not guarantee the review of incomplete or incorrectly completed accreditation applications. The organizer makes the final decision to approve or reject each application. The organizer reserves the sole right to decide which media representatives will be issued media passes and vests.

Approval for accreditation (sent to the email provided in the application) will be given within five working days after the application is received.

## MEDIA CARDS AND VESTS COLLECTION AND RETURN

Accredited media representatives can pick up and return media cards and vests at the media center. These can only be collected personally upon presenting a signed confirmation of accreditation. By submitting your accreditation application, you confirm that you have read, understood, and agree to the safety regulations for media representatives and the accreditation rules. You also accept full responsibility for your conduct. The event organizer reserves the right to revoke the accreditation card and/or vest if the rules are violated.

## Motorsport can be dangerous!

Despite the organizer's efforts to ensure safety and precautionary measures, unexpected accidents can occur in motorsport. Spectators are fully responsible for their safety and must continuously assess whether their safety is at risk during the event. Spectators are obliged to follow the instructions of the event personnel.
